- 4 I agree that any personal belongings placed in the common areas without permission or left in the dormitory after moving out will be disposed of.
- 5 I accept without objection any disciplinary action for violations of the rules and regulations contained therein (see reverse side).
- 6 In the event of an emergency situation, or if regular/urgent inspection of my room is necessary, I agree to allow Senbaru Dormitory staff to enter my room in my absence.
- 7 I agree to comply with administrative requests to make changes to my allocated room.

Conduct Subject to Eviction from Dormitory

1 Conduct that contravenes communal life

- (1) Forcing someone to drink alcohol on the dormitory premises
- (2) Smoking on the dormitory premises
- (3) Loud activities in the dormitory (automobile/motorcycle engine noise, loud voices, loud volume of sound from television, radio, musical instruments, microphones and other audio equipment)
- (4) The act of keeping pets or animals such as dogs, cats, reptiles, insects, fish, etc.

2 Conduct that contravenes public morality

- (1) Allowing a person of the opposite sex to enter a room without permission from dormitory staff
- (2) Indecent behavior
- (3) Distributing or dissemination of obscene materials

3 When a resident is judged to be unsuitable for communal living due to illness or other health reasons

- (1) In case of infectious diseases such as tuberculosis and/or other illnesses
- (2) Willful failure to maintain basic standards of cleanliness and regular disposal of refuse

4 Conduct that significantly violates or obstructs the Dormitory's code of management and operation

- (1) Placing one's personal belongings in common areas such as living rooms, hallways, etc.
- (2) Attaching power extension cords to power outlets in common areas for private consumption of electricity
- (3) Connecting personal wiring and/or electrical appliances to shared power outlets, etc. in common areas
- (4) Causing dangerous situations, such as fires, when using the kitchen, etc.
- (5) Any act that causes loss, damage, or defacement of the Dormitory's facilities, fixtures and/or equipment.
- (6) Other acts deemed by the University as a flagrant violation of the Dormitory's code of management and operation
